

## CCPA Privacy Policy

JAMCO Corporation, its subsidiaries and affiliates (hereinafter “JAMCO Group”) hereby set forth this Privacy Policy in order to appropriately handle the personal information of our consumers who are residents of California pursuant to the California Consumer Privacy Act of 2018 and Regulations thereto (hereinafter collectively referred to as the “CCPA”).

### <1> Categories of Personal Information JAMCO Group collects

JAMCO Group has collected the following categories of personal information from you within the last twelve (12) months and will continue collecting the following categories of personal information.

Category - Personal information categories listed in the California Customer Records statute (California Civil Code Section 1798.80 (e))

Information - Name, address, telephone number, and e-mail address.

JAMCO Group collects the above personal information directly from you.

### <2> Purposes of Collecting of Personal Information

JAMCO Group collects your personal information in order to achieve the following purposes:

- (i) Execution of contracts;
- (ii) Development and provision of better products, services and experiences you expect from us;
- (iii) Compliance with legal or regulatory obligations and exercise of rights;
- (iv) Communications with you or your business partners, including sending greeting cards; and
- (v) Other purposes incidental or related to any of the above.

If personal information is to be collected for any purposes other than above, JAMCO Group will notify you, clearly setting forth the purpose of collecting and scope of such information. JAMCO Group will obtain your consent prior to such personal information being collected.

### **<3> Sharing or Disclosure of Personal Information**

If JAMCO Group is to share or disclose your personal information to a third party, JAMCO Group will make the transfer only after obtaining your consent, unless the sharing or disclosure fall under any of the exemptions under the CCPA. In such case, JAMCO Group will select the third parties with care, and request that they take the same appropriate measures in the management of personal information pursuant to the CCPA.

In the last twelve (12) months, JAMCO Group has not shared or disclosed your personal information to any third party,

### **<4> Sales of Personal Information**

JAMCO Group has not sold any personal information to any third party in the last twelve (12) months.

JAMCO Group does not sell the personal information of its customers who are under sixteen (16) years of age.

### **<5> Your Rights under the CCPA**

Pursuant to the CCPA requirements, you may exercise each of following:

#### **(1) Access Right to Specific Information**

You have the right to request that we disclose certain information to you about our collection, sharing, disclosure or use of your personal information over the past twelve (12) months from the time of your request (“Access Right”). In responding to a verified request to know the categories of personal information, JAMCO Group will provide:

- The categories of personal information JAMCO Group has collected about you in the preceding 12 months;
  - The categories of sources from which the personal information was derived;
  - The business or commercial purpose for which JAMCO Group collected the personal information;
  - The categories of third parties with whom JAMCO Group shares personal information;
  - The specific pieces of personal information JAMCO Group has collected about you;
- and

- The categories of personal information that JAMCO Group disclosed for a business purpose in the preceding 12 months, and for each category identified, the categories of third parties to whom it disclosed that particular category of personal information.

### **(2) Deletion Request Right**

Unless an exception applies under the CCPA, you have the right to request that we delete any of your personal information that we collected from you and retained (“Deletion Request Right”).

### **(3) Do Not Sell (No Right to Opt-Out)**

JAMCO Group has not sold and will not sell any personal information collected from consumers.

### **(4) Right to Non-Discrimination**

You have the right not to receive discriminatory treatment by JAMCO Group for the exercise of the privacy rights conferred by the CPPA. Discrimination includes:

- Denying goods or services to you;
- Charging different prices or rates for goods or services, including through the use of discounts or other benefits or imposing penalties;
- Providing a different level or quality of goods or services to you; and
- Suggesting that you will receive a different price or rate for goods or services or a different level or quality of goods or services.

### **(5) Exercising Access and Deletion Rights**

To exercise the Access and Deletion Request Rights described above, please submit a verifiable consumer request to us by contacting JAMCO group in the manner set forth in Section 6 (either by e-mail or postal service).

Only you, or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable consumer request related to your personal information.

The verifiable consumer request must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative thereof (e.g. a copy of your passport, residence certificate, etc.); and
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond thereto.
